At a reception organised on Friday 11 December 2015, Carlo Thill, Country Head of BNP Paribas and Chairman of the BGL BNP Paribas Management Board, and the staff delegations of the BNP Paribas Group in Luxembourg presented four cheques for a total value of EUR 97,825 to the Médecins du Monde Luxembourg, Parkinson Luxembourg, Rahna Asbl and Multiple Sclerosis Foundation organisations in the name of the Group's employees.
