History:

TEB (*the "Bank"*) was initially founded under the title of Kocaeli Halk Bankası T.A.Ş. and in 1927. The Bank was acquired by Çolakoğlu Group in 1982 and renamed as "Türk Ekonomi Bankası A.Ş."

15.63% of TEB's shares are traded on the Istanbul Stock Exchange National Market as of December 31st, 2010 under the TEBNK ticker. TEB shares are also listed on the London Stock Exchange's depository receipt market. Up-to-date information concerning TEB's shareholding structure and TEB shares can be found on the Bank's web site at www.teb.com.tr. Since February 10th, 2005, TEB has become a BNP Paribas joint venture*.

Your contacts in TEB

Please follow the steps stated below

1. Call Telephone Number 00 90 444 0 766 TEB Star Contact Center which is dedicated to Priority and gives service in English everyday between 09:00 - 24:00 Istanbul time (+1 hour according to Central European Time)
2. Give the following information to our dedicated contact center agents to help them organize your contact with our RMs:
 - Your Name & Surname
 - Your reachable phone number and e-mail address
 - Date of arrival in Turkey
 - Your destination in Turkey (*City*)
 - Length of stay in Turkey
 - Which banking services you will need
3. Take an appointment from the Relationship Manager who will call you as soon as possible

List of documents you will need

- Short Residence (*Less than 6 months, without work permit*)

In order to open an account you need to have a tax number (*VKN*), you may apply for a tax number from revenue administration offices.

Necessary documents for tax number (*VKN*) application: Passport

- Residence more than 6 months (*without work permit*)

If you plan to stay in Turkey for more than 6 months, you will need to apply for a foreign identity number from the foreign bureau office of the district you will reside. For more information please contact with the authorities.

Necessary documents for opening an account at TEB: Passport, Tax number or Identity Number for Foreigners.

And a Priority membership card or a credit card with the Priority logo or an introduction letter.
