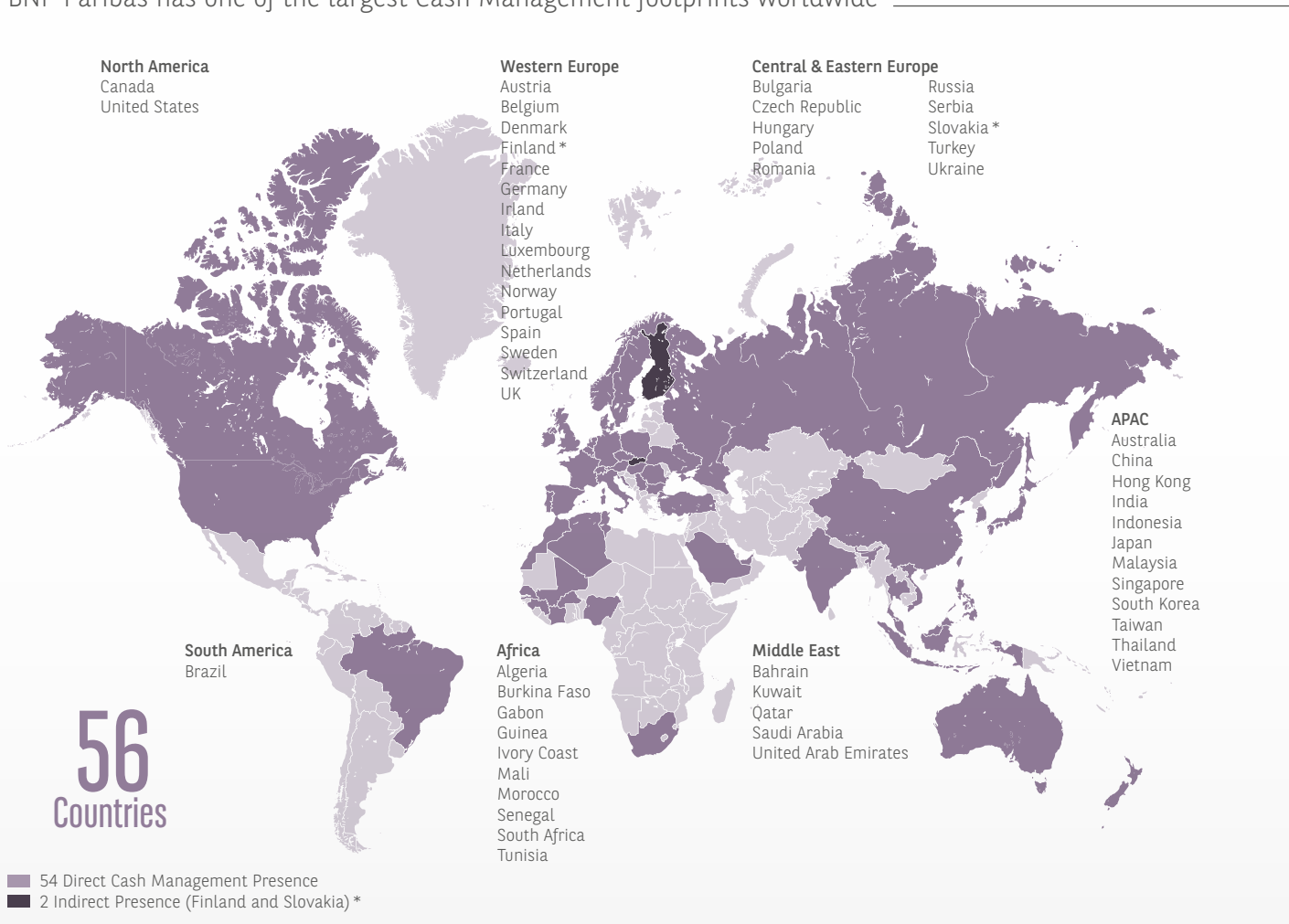

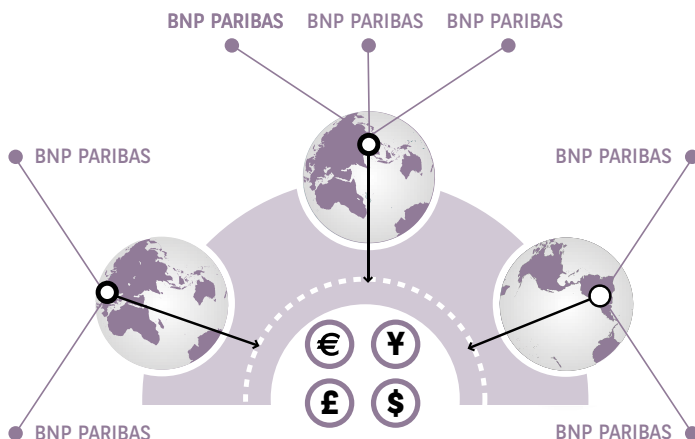

MultiLine - If you operate mainly in Luxembourg and the Grande Région

MultiLine is an electronic multi-bank tool designed specifically for companies based in Luxembourg. Through LuxTrust, the Luxembourg certification authority, it provides secure access to the domestic accounts you hold with BGL BNP Paribas and other Luxembourg banks. You can make credit transfers and direct debits in electronic form individually or by inputting files. You can check the status of your accounts and transactions at any time. You can also parameterise user administration and access rights.

Connexis Cash - If you need global reach on your cash and payments

Connexis is an open-ended modular solution consisting of an online platform of integrated customised services that meet your needs and requirements while ensuring flexible and optimal administration of your users' rights. Connexis provides a highly secure web-based work area that allows you to monitor your accounts in real time and gain access to multi-site and multi-bank transactional services. All your accounts with BGL BNP Paribas, the BNP Paribas group and other banks, if any, are accessible through a single gateway. With Connexis you can enter individual or batch electronic payments by importing files or directly inputting data and monitoring the status of your accounts and transactions. Most international formats (MT101 FIN, XML and many local formats) are already operational. Interfaceable with your own Treasury Management System (TMS) and Enterprise Resource Planning (ERP), Connexis features a special Liquidity Management module that allows you to monitor accounts integrated into a cash pooling system.

Multibank Electronic Reporting

Your end-of-day account statements and intraday balances and credits/debits are sent by fast, simple and secure remote transmission to a BIC address of your choice through the SWIFT network (FIN and/or FileAct) or in XML format.

Remote Payment Initiation IN

With Remote Payment Initiation IN (RPI-IN) you can forward your payment instructions either directly or through another bank to BGL BNP Paribas, which will execute them for you. RPI-IN is a standard, international multi-bank communication solution based on using the SWIFT private network (FIN and/or FileAct) or in XML format.
